

The 100 points of ID requirements are stipulated by SafeWork NSW and must be adhered to in full to be certified.

Identity Requirements (Mandatory)

Students must bring **evidence of identity for 100 points in the original and physical document form** (see below). We CANNOT accept any photos, scans or photocopies. Our White Card Course is licenced though SafeWork NSW and we **must** deliver the program as per their requirements:

- o Within the 100 points, applicants must show the following:
 - Current NSW Residential Address
 - Date of Birth
 - Full Legal Name
 - Signature
 - Photo

A combination of secondary documents is allowed to make up 100 points however if more than one credit or ATM cards, or bank statements are used they MUST be from different financial institutions. **MUST BE VALID ORIGINAL DOCUMENT / CARD ISSUED IN AUSTRALIA**.
